Today's event is in fulfilment of relevant provisions of the NCR Act that includes Section 41 (1) "the Integrated NCR System shall be the basic information system in Sierra Loene in respect of Registration of personal data of individuals". Section 41 (2) "The <u>Authority</u> shall on the basis of the Integrated NCR System provide personal data to other Government Information systems and also receive from them". Section 41 (3) provides that "the personal registration data provided by the Integrated NCR System shall be the primary source of authoritative information as against other information systems providing administrative services to the population"

#### Identity Data within the DEL
